SCHOOL-PARENT COMPACT

School Responsibilities

The Franklin School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:**

The Franklin School will provide high-quality curriculum and instruction for our students in a safe environment conducive to learning. Students will receive a well-rounded education which includes the core-curricular subject areas such as math, literacy, social studies and science as well as health, physical education, music, art and character education.

- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:

The parent-teacher conferences will be held on December 1, 2, 3, 2010 and April 19, 20, and 21, 2011.

The school will provide 4 quarterly report cards and 4 quarterly interim reports.

4. **Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows: *Any day during the teacher's preparation period with advanced notice.*
5. **Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities,** as follows: *Two days during the school year parents are able to observe their students in the classroom. (Walk in your child's footsteps in November, 2010 and Come to School with your child in March, 2011. Other daytime school activities include Muffins with Mom and Grandmom in May and Donuts with Dad and Granddad in June.*

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

The Franklin School will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
