## PART I. GENERAL EXPECTATIONS

The Robbins School agrees to implement the following statutory requirements:

- The school will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating school students.

1. **Robbins School will distribute a monthly calendar providing pertinent information to all our parents. This information will be sent in English and Spanish.**
