SCHOOL-PARENT COMPACT

The Washington Elementary School, and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

School Responsibilities:

Washington Elementary School, working cooperatively and effectively with parents and/or guardians to provide for their participation in the successful education of their children will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards through:
 - *Challenging and rigorous curricula aligned with the New Jersey Core Curriculum Standards,*
 - *Highly qualified teachers and paraprofessionals,*
 - *Comprehensive professional development for staff which is based on best practices,*
 - *Scientifically based programs and strategies,*
 - *Use of data to inform, drive, and individualize instruction to maximize learning.*
 - *Special Education Programs for students who need the services.*
2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:
 - *Formal Parent/Teacher conferences are held twice a year: December and April,*
 - *And as needed by teacher or parent request throughout the academic year.*
3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:
 - *Interim Reports and Report Cards four times a year,*

- *Individual student reports for the NJ ASK 3 and the ACCESS Test, which are State of New Jersey mandated tests.*
4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:
- *Staff will be available to parents at Back to School Night, Parent/Teacher Conferences, through scheduled conferences, by phone, written notes and through e-mail.*
5. Parents will have opportunities to volunteer and be an integral part of the educational process of their children by participating in school activities throughout the school year, such as:*
- *Assisting teachers in the classrooms (classroom helpers),*
 - *Supervising and managing the school's book fair,*
 - *Participating in Family Nights.*
 - *PTO, and*
 - *Special events in the classroom and the school*

Parent Responsibilities

- *Supervising the completion of student homework and studying,*
- *Making sure that my child reads every night on his/her own or with me,*
- *Providing opportunities for literacy and math activities at home,*
- *Participating, as appropriate, in decisions relating to my children's education,*
- *Informing the teacher if my child is having problems with learning,*
- *Attending parent/teacher conferences and at least two events during the school year,*
- *Expressing high expectations for my child and offering praise and encouragement for achievement,*
- *Volunteering in my child's classroom and school activities,*

- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.*
- *Support the school in developing positive behaviors*
- *Provide a home environment that encourages my child to learn*
- *Stay aware of what my child is learning*

OPTIONAL ADDITIONAL PROVISIONS

We, as students at Washington Elementary School, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- *Demonstrate respect for myself, other students and adults,*
- *Follow the rules and regulations of the school.*
- *Let my teacher and family know if I need help,*
- *Follow all classroom and school rules,*
- *Complete all my assignments to the best of my ability,ea*
- *Respect other people, property, and the community,*
- *Do my homework every day and turn it in when it's due.*
- *Read at least 30 minutes every day outside of school time.*
- *Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.*

The Washington Elementary School will:

Plan de Participación de Padres de la Escuela Elemental Washington

La Escuela Elemental Washington ha desarrollado conjuntamente con los padres, profesores, personal, y los estudiantes un plan de participación entre los padres y la escuela. Este plan establece las expectativas de la participación entre los padres y la comunidad con la escuela Washington, una escuela ayudante de Título I.

Anualmente, la Escuela Elemental Washington celebrará una Noche de Regreso a la Escuela, a la que serán invitados todos los padres. En esta reunión, la directora y el personal de la escuela informan a los padres de la participación en el programa Título I y explicaran los requisitos del Título I, y el derecho de los padres a que participen en la escuela.

La Escuela Elemental Washington tiene una serie de reuniones para los padres a tiempos variados para la conveniencia de los padres. Entre ellas figuran las reuniones del Consejo de la Comunidad y la Escuela, reuniones de PTO, conferencias de entre Maestro y los Padres, capacitación para padres en forma de noches de lectura y reuniones de información para padres. Reuniones han sido y seguirán siendo llevadas a cabo cuando los padres están involucrados en una manera organizada, continua y oportuna en la planificación, revisión y mejoramiento de los programas para la participación de los padres y de la comunidad.

La Escuela Elemental Washington proporcionará a los padres información oportuna sobre los programas y servicios a través del boletín mensual del PTO, calendario mensual, reuniones del PTO, comunicación telefónica, correo electrónica, y otros eventos.

La Escuela Elemental Washington provee a los padres la descripción y explicación de los planes de estudio en uso en la escuela, las formas de evaluación académica para medir el progreso, y los niveles que se espera que los estudiantes cumplan. Esto se hace a través de reuniones de padres, conferencias, notas de tareas en carpetas, el boletín mensual del PTO, boletines de las aulas, el calendario mensual...

La Escuela Elemental Washington ha elaborado conjuntamente con los padres un compacto entre los padres y la escuela.
